Footnote (1): Conversion from Prime Farmland to Other Land is primarily due to the delineation of levees on Ryer Island, along Cache Slough, Lindsey Slough, Ulatis Creek, and improved mapping of canals and freeways.

Footnote (2): Conversion from Grazing Land to Other Land is primarily due to marsh land in the Hill Slough area, Lindsey Slough, Montezuma Slough, and Decker Island.

Footnote (3): Conversion from Urban and Built-up Land is primarily due to a lack of sufficient infrastructure, abandoned projects and the use of detailed digital imagery to delineate more distinct urban boundaries. Examples include cleanup of portions of the Northeast section and runway of Travis Air Force Base, Spyglass Hill Open Space, and the undeveloped areas of Mare Island, the cities of Benicia and Rio Vista, the Rio Vista Municipal Airport, and the closure of Green Tee Golf Club in Vacaville.

Footnote (4): Water related conversions are due to linework improvements primarily along the San Pablo Bay, Sacramento River, Lagoon Valley Reservoir, Lake Herman, Lake Madigan, Carquinez Strait, and the sloughs within the county.
