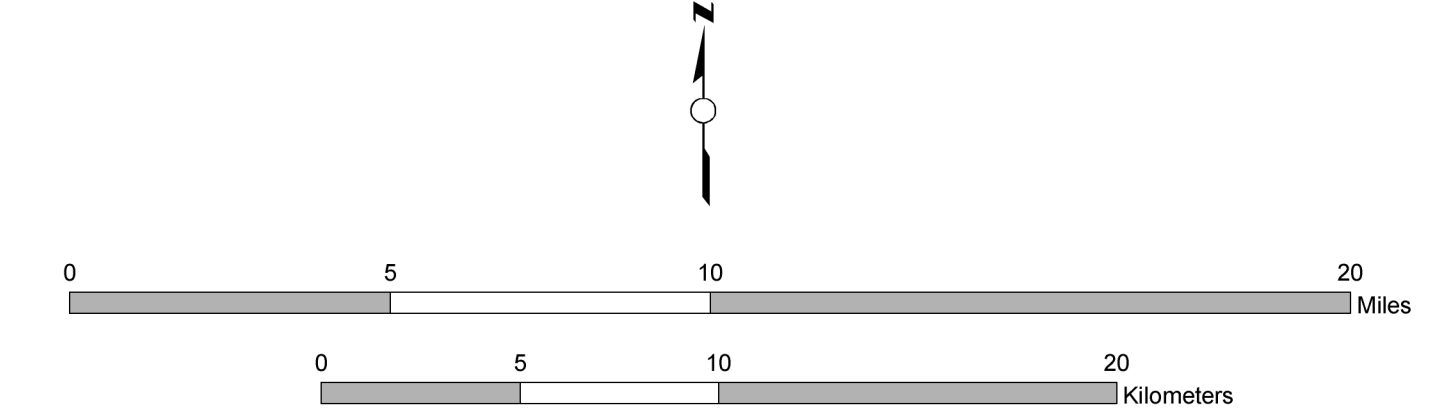
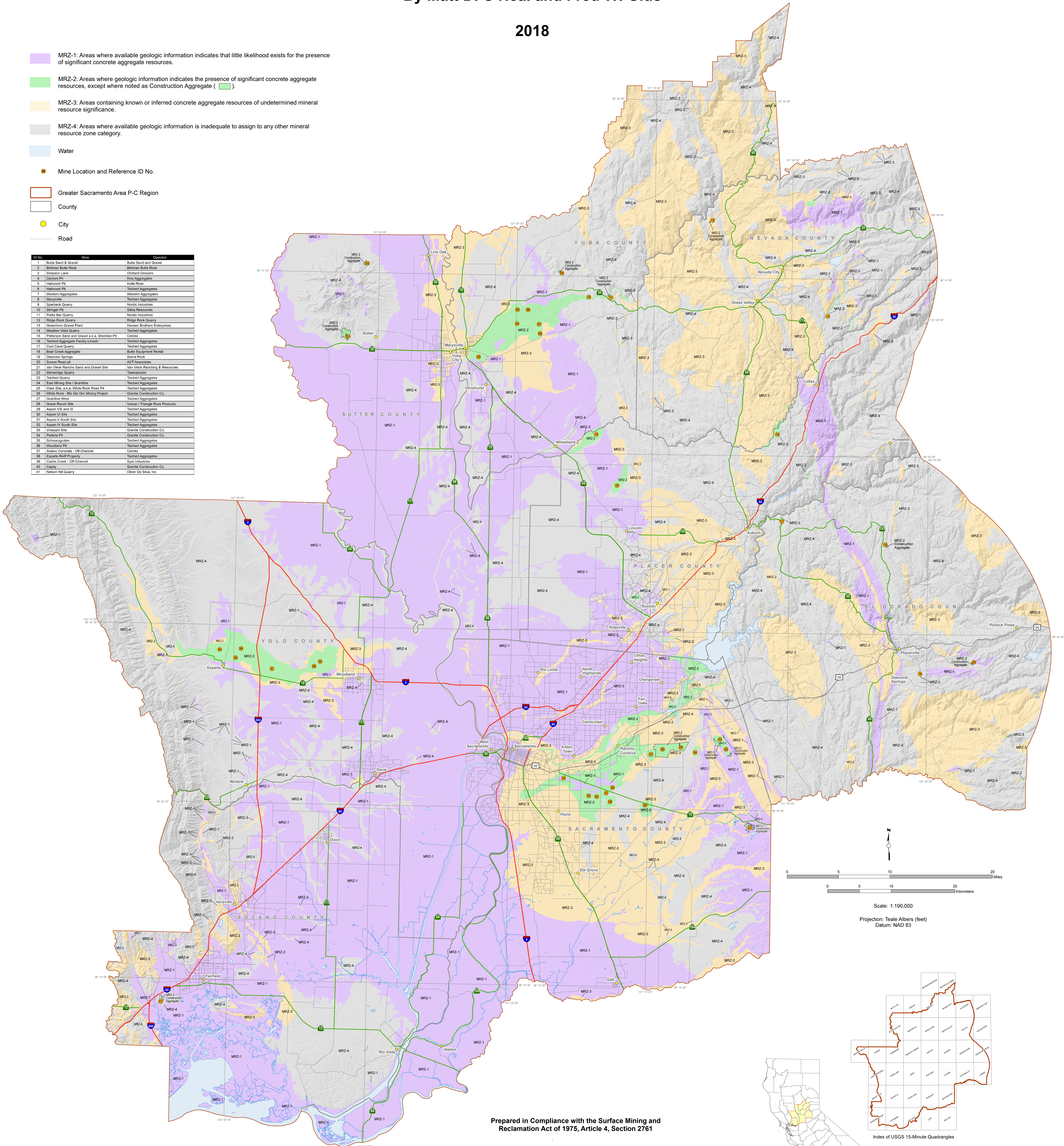

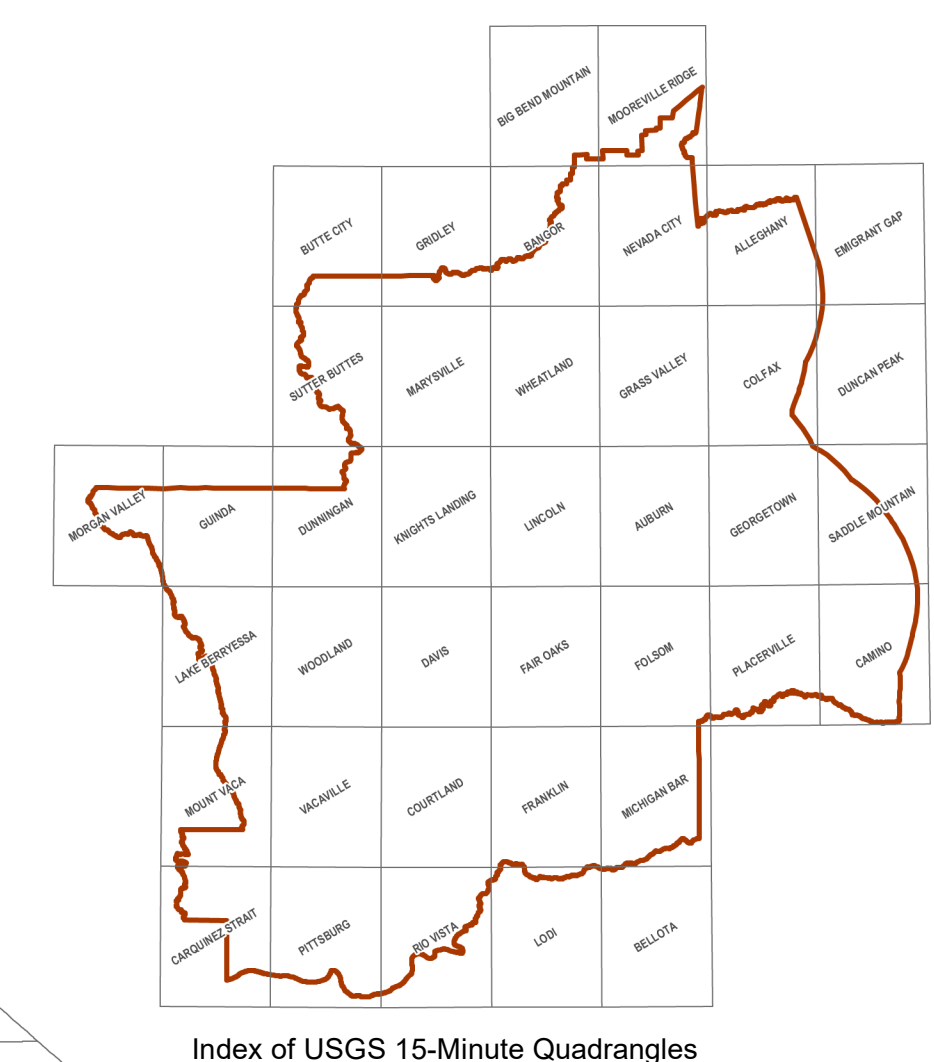
- MRZ-1: Areas where available geologic information indicates that little likelihood exists for the presence of significant concrete aggregate resources.
